As a true and lawful agent and attorney of the grantor named above for an in the name, place and stead of said grantor from this date in an Customs District and in no other name, to make, endorse, sign, declare, or swear to any entry, withdrawal, declaration, certification, bill of lading, or other document required by law regulation in connection with the importation, transportation, or exportation, or exportation of any merchandise shipped or consigned by or to said grantor, to perform any act or condition which may be required by law or regulations in connection with such merchandise; to receive any merchandise deliverable to said grantor.

To sign seal and deliver to and as the act of said grantor any bond required by law or regulation in connection with the entry or withdrawal of imported merchandise or merchandise exported with or without benefit or drawback, or in connection with the entry, clearance, lading, unlading or navigation of any vessel or other means of conveyance owned or operated by the said grantor, and any and all bonds which may be voluntarily given and accepted under applicable laws and regulations, consignee's and owner's declarations provided for in section 485, Tariff Act of 1930, as amended, or affidavits in connection with the entry of merchandise:

To sign and swear to any document and to perform any act that may be necessary or required by law or regulation in connection with the entering, clearing, lading, unlading, or operation of any vessel or other means of conveyance owned or operated by said grantor:

And generally to transact at the customhouses in any and all customs business, including marking, signing, and filing of protests under section 514 of the Tariff Act of 1930, in which said grantor is or may be concerned or interested and said agent and attorney full power and authority to do anything, whatever requisite and necessary to be done in the premises as fully as said grantor could do if present and acting, hereby ratifying and confirming all that the said agent and attorney shall lawfully do by virtue of these present: the foregoing power of attorney to remain in full force and effect until notice of revocation in writing is dully given to and received by the District Director of Customs of all districts. If the donor of this power of attorney is a partnership, and said the power shall in no case have any force of effect after the district. To authorize other Customs Broker to act as grantor's agent.

If you are the importer of record, payment to the broker will not relieve you of liability for Customs charges (duties, taxes, or other debts owned Customs) in the event the broker does not pay the charges. Therefore, if you pay by check, Customs charges may be paid with a separate check payable to the "Bureau of Customs and Border Protection" which shall be delivered to Customs by the broker.
